- c. Associates should follow all guidelines, rules & regulations from AMFI, IRDA, SEBI and other authorities.
- d. All disputes fall under the jurisdiction of Kolkata only.

2. Commission Payment:

- a. In case of IPOs, the commission structure will be communicated to you through a separate circular for every issue.
- b. For all IPOs, you will be paid commission on the amount allotted with application bearing your Code. A statement giving details of the applications allotted under your code the commission due thereon will be made available along with every payment. The commission payment shall be made on receipt of the payment from the respective companies.
- c. For being eligible to commission on Mutual Funds (both ongoing as well as NFOs), you should be AMFI certified.
- d. For Mutual Fund (Ongoing schemes) you will be paid commission on a fortnightly basis based on the transaction confirmations received from the respective companies.
- e. On New Fund Offerings (NFOs) the commission payment shall be made on receipt of payment from the respective companies.
- f. As per the prevailing tax laws, Service Tax & other taxes as applicable will be deducted while making the payment.
